#### PROCEDURES

Our procedures are as follows:

- 1. BUYER issues Irrevocable Corporate Purchase Order (ICPO).
- 2. Make an introduction call or zoom, Seller and buyer for verification of information.
- 3. SELLER issues Full Corporate Offer (FCO).

3.1 BUYER signs and seals EACH page of the FCO and returns it to SELLER with ICPO SIGNED AND SEALED BY

BUYER WITH WARNING LETTER TO BUYER AND SELLER.

4. SELLER issues draft Sales Purchase Agreement (SPA) which will incorporate full terms and conditions.

4.1. Once the SPA has been verified and agreed, the shipment will proceed through DocuSign.

5. The BUYER signs and seals EACH page of the SPA by electronic means DocuSign within a period not exceeding 5 calendar days.

6. The SELLER completes the SPA, signs and stamps it and issues a pro-forma invoice, the proforma invoice

will be returned signed within 24 hours by the BUYER.

6.1 The buyer sends the following documents before starting the process and to avoid possible errors, in order to review and verify their performance in the transaction: (RWA Letter/POF)

Ready, Prepared and capable. The Buyer's bank sends MT799 (POF) to Seller's bank. Seller confirms buyer's funds.

7. The SELLER sends the "Prove of Product" within 5 business days. From notice MT705 informative.

The Prove of Product includes:

- a) Recent SGS report;
- b) The asset certificate;
- c) Manufacturing brochure.

8. Once the BUYER receive the "Prove of Product" from Seller. Within 3 International banking days the BUYER'S Bank (from top 50 Prime Banks) issues MT700 100% IRREVOCABLE NON-

TRANSFERABLE DLC AT SIGHT, which the SELLER'S Bank reviews and approves.

9. SELLER issues 2% Performance Bond to BUYER.

10. BUYER will be invited to the loading port for the inspection during the loading at the BUYER'S expense.

11. Shipments will start within 15 days of the MT700 100% IRREVOCABLE NON-TRANSFERABLE DLC AT SIGHT approval from the BUYER'S bank.

12. All the original documents will be sent to the BUYER bank via the SELLER bank through DHL. 13. Product loading and shipping begin as scheduled. Bank Guarantee MT700 100% IRREVOCABLE NON-TRANSFERABLE DLC AT SIGHT Buyer releases payment via MT103 Express Funds Transfer to seller for full shipment value when vessel is TRANSPORTED "AGAINST SHIPPING DOCUMENTS" and receives all relevant shipping and export documents.

14. The Seller makes the first OCEAN SHIPMENT. The Seller, having verified the Payment at the LOADING port, prepares for the same process for the next delivery.

#### Note:

-This document and the data contained therein are valid for 5 working days from the date of the same, after this period and if we do not receive confirmation from the customer all elements including prices and other information will be without Effect.

-Once the contract is signed we have 7 days to proceed as established in said document article 4 (4.COMMODITY DESCRIPTION) article 5 (5.PAYMENT TERMS) article 6 (6.PROCEDURES), after the established period, they will communicate in writing by letter Named the situation, which we will study and respond with a possible extension if appropriate, given the circumstances of the volatility of the commodities in customs we are subject to the fluctuations of the international market, the demand or supply.

-If the customer wants his own labelling, the price will have to be considered separately -Bear in mind that we will only provide the necessary documentation for the analysis procedure, such as: GACC; SIF;phytosanitary certificates, certificates of origin and others, always after the signature of the LC

-If the Buyer wishes to check the quality of product, he can send a trusted person at the Loading Port, assist at the SGS Inspection and check the Product.

- Only financial instruments issued by Top 50 Banks are accepted. All 10 largest banks in Singapore are accepted as they areAA rated, including UOB Kay Hian Private Limited. -The possible subsequent deliveries will be load on vessel only after payment confirmation of previous delivery by seller bank
