SBLC / DLC PROCEDURES:

- 1. BUYER ISSUES IRREVOCABLE CORPORATE PURCHASE ORDER ICPO, ACCORDING TO SELLER'S TERMS
- WITH FULL BANKING DETAILS OF THE BUYER THEN SHOULD SEND IT BY EMAIL TO THE SELLER'S EMAIL.
- 2. SELLER ISSUES THE DRAFT CONTRACT SPA AND INCLUDES A VERBIAGE DRAFT OF SBLC/MT760.
- 3. BUYER RETURNS THE SIGNED DRAFT CONTRACT SPA WITH SIGNED VERBIAGE DRAFT OF SBLC/MT760.
- 4. SELLER SIGN THE SPA THEN WILL SEND IT BACK TO THE BUYER BY EMAIL.
- 5. BUYER BANK ISSUES IRREVOCABLE, CONFIRMED, DIVISIBLE, RENEWABLE, TRANSFERABLE, OPERATIVE, FULL CASH BACK (SBLC/MT760) TO SELLER.
- 6. SELLER WILL ISSUE THE **(PPOP & ANY OTHER IMPORT CERTIFICATES REQUIRED BY THE BUYER)** AND SEND IT TO THE BUYER.
- 7. SELLER WILL ISSUE THE PROFORMA INVOICE AND EMAIL IT TO THE BUYER.
- 8. WITHIN 30-60 DAYS AFTER (SBLC/MT760) CONFIRMATION, SHIPMENT COMMENCES ACCORDING TO DELIVERY SCHEDULE.
- 9. BUYER'S BANK RECEIVE THE SHIPMENT DOCUMENTS COPY (BANK TO BANK) BY EMAIL. SELLER'S BANK SEND TO BUYER'S BANK THE EXPORT DOCUMENTATION, BUYER WIRE MT103 AT LOADING PORT, SELLER'S BANK SEND THE ORIGINAL DOCUMENTS (BANK TO BANK) AGAINST THE MT103.

 10. SUBSEQUENTLY MONTHLY SHIPMENT CONTINUES AS PER TERMS AND CONDITIONS OF THE SALES AND PURCHASE AGREEMENT CONTRACT BETWEEN BUYER AND SELLER.

ESCROW PROCEDURES:


1. BUYER ISSUES IRREVOCABLE CORPORATE PURCHASE ORDER ICPO, ACCORDING TO SELLER'S TERMS

WITH FULL BANKING DETAILS OF THE BUYER THEN SHOULD SEND IT BY EMAIL TO THE SELLER'S EMAIL.

- 2. SELLER ISSUES THE DRAFT CONTRACT SPA AND INCLUDES AN ESCROW AGREEMENT.
- 3. BUYER RETURNS THE SIGNED DRAFT CONTRACT SPA AND THE ESCROW AGREEMENT.
- 4. SELLER SIGN THE SPA AND ESCROW AGREEMENT, THEN SEND IT BACK TO THE BUYER BY EMAIL.
- 5. BUYER BANK SEND MT103 SWIFT TRANSFER OF 100% OF THE VALUE TO THE ESCROW ACCOUNT.
- 6. SELLER WILL ISSUE THE **(PPOP & ANY OTHER IMPORT CERTIFICATES REQUIRED BY THE BUYER)**AND SEND IT TO THE BUYER.
- 7. SELLER WILL ISSUE THE PROFORMA INVOICE AND EMAIL IT TO THE BUYER. SELLER IS ALLOWED 25% DEPOSIT FROM ESCROW TO UTILIZE INTO PRODUCTION.
- 8. WITHIN 30-60 DAYS AFTER ESCROW FUNDS CONFIRMATION, SHIPMENT COMMENCES ACCORDING TO DELIVERY SCHEDULE.
- 9. BUYER RECEIVE THE SHIPMENT DOCUMENTS COPY BY EMAIL. SELLER SEND TO BUYER THE EXPORT

DOCUMENTATION, BUYER RELEASES THE ESCROW FUNDS AT LOADING PORT.
