# Chicken Paws Specifications

## 1 Quality and Processing

Grade A (PAW) quality, processed using BQF (Block Quick Frozen) method. Cut at the level of joints, meaty with normal fat coating. 100% fresh and frozen, with white skin and well-dressed appearance.

## 2 Size and Weight

Average weight per piece: 35-45 grams. Average length per piece: 9-12cm. Ensures consistency in product size for better portion control and presentation.

## 3 Freezing and Storage

Frozen at -40°C, stored at -18°C, and transported at -20°C. Shelf life of 24 months. Ice content less than 0.3%, ensuring product integrity and quality preservation.

## 4 Quality Assurance

No black pads, ammonia burns, bad smells, excessive blood, broken bones, bruises, feathers, or hairs. Fresh and hard nails. Moisture content less than 2%. Production age not more than 60 days from shipping date.



# Chicken Wing Specifications

## Quality and Processing

Grade A, Halal processed chicken wings from Brazil. Fresh and clean with no yellow skin, bad smell, feathers, bruises, or ammonia burns. BQF (Block Quick Frozen) freezing process ensures optimal quality preservation.

## Size and Storage

Average weight of 30 grams per piece, length 7-11 cm. Quick frozen at  $-40^{\circ}\text{C}$ , stored and transported at  $-18^{\circ}\text{C}$ . Impressive 24-month shelf life for long-term storage and flexibility in use.

## Packaging and Certifications

Packed in 20 kg cardboard boxes with factory labels in English and Chinese. Certified HACCP, HALAL, and ISO, ensuring adherence to international quality and safety standards.

# Quality Assurance Measures

## Microbiological Standards

Total bacterial count should not exceed one million cells/gram. Meat must be free from Salmonella bacteria, Staphylococcus Aureus, and Shigella (in 1000 gram specimen).

## Chemical Standards

External fat should not exceed 5 ml equivalent / 1 kg. Chicken meat will be free from radiation. Peroxide number should be within acceptable limits.

## Additional Safety Measures

Meat should be free from colonic whole toxigenic and whole pathogenic bacteria, spores of fungi, and yeasts. Clonic group shouldn't exceed 3000/grams of chicken meat.



# Packaging and Labeling

## Packaging Options

Outer packaging: Standard 20kg cardboard box. Inner packaging: Four 5kg layers or according to capability. Three presentation options for whole chickens: 1, 2, or 3 chickens per pack.

## Labeling Standards

Standard International Labels accepted by China Authorities and China Customs for Frozen Poultry. Factory labels on boxes in English and Chinese, ensuring clear communication of product details.

## Information Included

Labels include essential information such as origin, product type, weight, processing date, expiration date, and storage instructions. This ensures compliance with international standards and facilitates easy identification.
