PAYMENT AND DELIVERY TERMS

The Buyer and the Seller hereby agree to and fully accept the following payment terms procedures for the execution of the "Transaction" by both "Parties":

- A. Buyer will instruct his bank to issue a SBLC Letter of Credit Via MT 760 Operational, Irrevocable, Transferable, Divisible, by the value of the trial for the first delivery valid for 90 days.
- B. For the delivery of the contract the buyer's bank will issue a Letter of Credit SBLC via MT 760 Operational, Irrevocable, Transferable, Divisible, for the value of one month of delivery as a guarantee valid for 370 days, issued in both cases by a top 25/50 bank.
- C. Seller will issue a PB2% for the value of the SBLC 3 working days upon receipt of the Letter of Credit.
- D. Final payment is via TT MT103 after goods arrival at destination port and within 48hrs. to the issuance of the quality inspection report.

PROCEDURES:

- A/ Seller sends this SCO to the buyer for amendment.
- B/ Buyer Sends ICPO to the Seller + Passport+ KYC.
- C/ Seller sends Draft – Contract to the Buyer.
- D/ Buyer amends the Draft – Contract.
- E/ After acceptance from the Seller, both parties sign the final contract and exchange it.
- F/ Buyer issues the draft SBLC for approval by the seller's bank.
- G/ Once the SBLC Draft is approved, The Buyer issues Irrevocable Letter Credit SBLC-MT760 to the Seller's Bank.
- H/ The Seller's bank will implement the 2% Performance Bond to the Buyer's Bank as a guarantee of performance.
- I/ Seller delivers the product to the port of discharge with all the documents.
- J/ After successful CCIC/CIQ/SGS Inspection at discharge port, buyer pays for the first monthly shipment within two (2) days via TT MT103.
- K/Seller transfers title of product to Buyer.
- L/ Shipments continue according to the delivery program.
