SODIUM SULFATE PURCHASE PROCEDURE

(LITHIUM CONCENTRATE)

1. The Buyer through his Representatives, Brokers, Facilitators, makes a purchase intention. LOI
- 2.- The Brokers and Facilitators Representatives, sign an NCNDA.
- 3.- The selling Company issues an FCO to the Buying Company.
- 4.-Next, the purchasing company will issue an ICPO:
 - With Company Registration.
 - Passport of the legal representative. (copy)
 - Bank data.
 - KYC or CIS
- 5.- SPA, Draft, issued by the selling company. Which will carry out mutual corrections.

6 - The SPA is formalized before notaries, on both sides, and the buyer sends a draft of the Verbiage of the bank guarantee, for the approval of the seller.

7 - The buyer opens a letter of bank guarantee and delivers it to the seller's bank.

The selling Company will issue the following documents:

-Supply Commitment and dates.

-Analysis Reports and certificates issued by the SGS Certification Company,

- Certificate of origin.

- Data of the selling Company CPA. of issuance of the Company.

-The selling company will send the EXPORT AUTHORIZATION LICENSE CODE.

8.- The Brokers and Facilitators will send the selling Company an IMFPA Commitment contract that will be signed and returned for its guarantee.

9.- The selling company will deliver the product FOB in one of the agreed ports, prior coordination with the buyer, of sending his ship to load the product.

10 - When the cargo is certified, and the quality and quantity of the product by one of the international certifiers such as SGS or CCIC or similar, the buyer's bank must pay the seller, by MT 103 or with the payment guarantee.

11 - The seller pays what was agreed to the intermediaries.

12 - The dispatch of the following shipment is prepared, with the certification of the ship's contract through the buyer.
